#### CALL TO ORDER - NOTING OF ROLL BY CLERK

The meeting was called to order at 6:15pm by President Frutiger. Roll call: Wilkinson, Tebon and Frutiger present. Also present: John Doyle, Engineer Brian Berquist and Don Tierney.

### CONSENT AGENDA

Motion by Tebon and seconded by Wilkinson to approve the April 12, 2021 agenda as posted. All ayes, motion carried.

### A. APPROVAL OF MINUTES FROM MARCH 8, 2021

Motion by Wilkinson and seconded by Tebon to approve the minutes from March 8, 2021 as written. All ayes, motion carried.

#### **NEW BUSINESS**

### A. REVIEW & ACTION

### 1. DISCUSS/CONSIDER CHANGE ORDER #2 FROM RAYMOND P CATTELL, INC FOR TID #3 DOWNTOWN REVITALIZATION PROJECT

Berquist informed the committee that change order no. 2 is for work being done on the east side of S. Main south of the Village hall. The work consists of creating a pump out on the corner, moving the street light westerly and leveling and widening the sidewalks and the cost for the project will be \$41,000.

Motion by Tebon and seconded by Frutiger to approve change order #2 from Raymond P Cattell, Inc for the TID #3 downtown revitalization project and forward to the Village Board for final consideration. All ayes, motion carried.

## 2. DISCUSS/CONSIDER ACCEPTANCE OF RECENT IMPROVEMENTS AND RECOMMENDATION FOR PAYMENT NO 8, SAVANNAH PARKWAY PLAT

Berquist informed the committee that a walk-through inspection of the Savannah Park plat was conducted last week. Most of the punch list items listed in Berguist's letter dated April 8, 2021have been completed and he is recommended acceptance of the work performed in late 2020 and does not recommend withholding any building permits for this section. The next steps required before payment no. 8 will be made are:

- Improvement of all lots off of Robert Nelson Rd
- Finish grading and grass restoration at the soccer field/park site
- Completion reconstruction of N Nelson Rd along the plat boundary (pave ½ lane)
- Completion reconstruction of Liberty Street along the plat boundary

Motion by Tebon and seconded by Wilkinson to accept the work performed in 2020 and approve the issuance of building permits for this section. All ayes, motion carried.

### 3. DISCUSS/CONSIDER REMOVAL OF GAS MAIN/SERVICE TO AG BUILDING IN FIREMEN'S PARK

McCredie informed the committee that she had been contacted regarding the removal of the gas main/service to the Ag Building in Firemen's park. The service is not being used and if needed in the future a line can be run from Grand Ave.

Motion by Wilkinson and seconded by Tebon to approve the removal of the gas main/service to the Ag Building located in Firemen's Park contingent upon there being no cost to the Village. All ayes, motion carried.

- Public Work staff have been working on getting the parks ready for the May 1st opening

Liz-

John and I came up with a few ways to trim down my original idea for the southwest bumpout at Deerfield Street.

- -Confine the work to just the bumpout area (eliminate going south of there)
- -Only replace the mainline sidewalk (ignore the private concrete area behind the main slabs)
- -Consider allowing some of the "iffy" concrete flatwork in the original project to remain (instead of forcing Cattell to replace them)

Assuming all of those items are ok, it would end up only being \$6k of actual Village cost to add the bumpout in.

From our perspective, that is a good deal. If the \$6k is available, we would recommend pursuing it.
