President's Message

Greetings Village of Deerfield Citizens!



With the arrival of the winter season, I'd like to recap some of the following winter requirements:

Property owners are required to keep fire hydrants, sidewalks, and handicap approaches, located on their property, clear of any snow and ice. Doing so will allow our community to stay safe during the winter months.

Shoveling or blowing snow out into the street is against Village Ordinance 28-9 and failure to comply could result in a monetary fine. The best way to remove the snow from your sidewalk and driveway is to put it onto your lawn and any snow that you remove from the road should go on to the terrace. Although, the less snow you have in the terrace will help leave room for the snow that the plows remove from the streets.

TIF district #6 was created, allowing Truckstar to complete their construction and the lowering of W. Nelson Street. \$500,000.00 from TIF district #3 was used to issue grants to the downtown area. The other \$500,000.00 that was set aside for revitalizing parts of the downtown area, was used to install new sidewalk and gutters along downtown. In the Spring of 2021, this work will continue with the mill and overlay of Park Drive and the parking lot along Nelson Street.

I'd like to thank the entire Village Board, Village Employees, members of Committees or Commissions, Deerfield Volunteer Fire Department, Deer-Grove EMS and our Police Department for all their commitment and hard work they put forth to make the Village a great place for all of us to live. This pandemic has provided some challenges, but with the dedication of all, we have been able to still provide our citizens with the utmost of service.

In closing, I'd like to wish all of you a very safe and happy Holiday Season.

Keeping Deerfield Attractive

With so many Deerfield residents having to stay home due to the pandemic, we have noticed that a lot of you put this time at home to good use and made many improvements to your property. At the same time, some properties have not been kept up as required by Village ordinances. It is important that properties are maintained to keep Deerfield attractive to others and to maintain property values. Here are some reminders.

- Trash & Recycle containers need to be removed from the curb within 12 hours after pickup. (Ord. 26-34a)
- Pick up of bulk items must be scheduled in advance by calling 800-248-2373, otherwise these items will not be picked up.
- Tree limbs over sidewalks and streets need to be trimmed at a height of 14 feet from the ground. (Ord. 20-26(5))
- Yards and vacant lots must be cut when the length exceeds 8 inches. (Ord. 20-1a)
- Vehicles parked on street must have current license plates and cannot be parked in yards on any unpaved surface.
- Lawn mowers/trimers/leaf blowers are to be operated between the hours of 7:00 am and 8:00 pm. (Ord. 22-47c8)
- Snow and ice must be removed from sidewalks by 5:00 pm the day after a snow fall. (Ord. 28-9)

Also, should you notice a sidewalk that needs repairs because of a raised edge or cracks that make the area unsafe to walk, please let the Public Works Department know. They try to repair as many as they can during the summer months.

Please do your part to keep your property maintained both to be a good neighbor and in keeping Deerfield attractive.

Snow and Ice Reminders

Winter has come and here are some winter weather reminders to all Village residents:

- The Village plows during snow storms of 2 inches or more.
- Ice and snow from sidewalks must be removed by 5:00 pm on the day after a snow/ice event. If your sidewalk is not cleared by that time, the Village will remove it and charge you for the work, which carries a minimum charge of \$80.00.
- It is illegal to shovel, plow or blow snow into or across any Village street. Violators will be ticketed.

These rules are included in the Deerfield Village Code and are designed to keep Deerfield safe during the winter months. With everyone's cooperation, we can enjoy a safe winter season!

Parking Regulations – Winter and Alternate Side Parking

November 15 and April 15 alternate side parking regulations are in effect. Remember between 1:00 a.m. and 7:00 a.m. to park on the even side of the street on even dates and the odd side of the street on odd dates. Specially marked streets are excluded from the alternate parking. Vehicles found parked illegally will be ticketed and/or towed at the owner's expense.

Parking regulations are enforced regardless of weather conditions

Main Street parking is not allowed between 2:00 A.M. and 6:00 A.M. from November 15 through April 15. If you have questions regarding alternate side parking or any other winter rules, please contact the village office.

Utility Payments Online

There are a number of options you have when paying Village utility payments. You can drop your payment off at the Village Hall, or do the Automatic Payment Option that is internally processed at the Village Hall. <u> "Adopt a Hydrant" Program</u>

Individuals interested in keeping a fire hydrant free of snow in a four-foot radius from the hydrant are encouraged to "Adopt A Hydrant". Hydrants free of

snow allow quick access in case of an emergency. Contact the Village Hall at 608-764-5404 and register your intention!

Budget numbers for 2021 and Mill Rate for 2020 tax bills

The Village Board approved its local 2021 budget on December 7, 2020, resulting in a general levy for 2020 of \$1,247,348 and an est. mill rate of \$5.06. This, along with the budgets from other taxing authorities less the State School Credit, will result in an est. total mill rate of \$18.29; a decrease from 2019 of \$18.54.

The lottery credit for 2020 will be \$183.19 (for those who occupied their <u>primary</u> residence as of **January 1, 2020**) and the First Dollar Credit will be \$74.75. The assessed value of the Village increased to \$246,488,100 for 2020 which is an increase of \$1,987,400 over the 2019 value of \$244,500,700. This increase is attributed to the new housing growth.

Property Tax Payment Information

Tax collection for December/January payments will be accepted at the Village Hall during normal business hours.



If you wish to pay your tax bill in December, payments will need to be received at the Village Hall before the close of business (4:30 p.m.) on Thursday, December 31, 2020, or postmarked on or before December 31, 2020 to be credited in December of 2020.

For the two-installment payment plan, the first installment must be received before close of business (12:00 pm) on January 29, 2021, or postmarked January 31, 2021. Any payment received in the drop box or in person after 12:00 pm on January 29 will be considered late and late fees will be applied by Dane County. The second installment is due by July 31, 2021, to the Dane County Treasurer. Your mid-year bill will come directly from Dane County.

The Village Hall will be closed on December 24nd & 25th and January 1, 2021, for the holidays and property taxes will not be processed on these days.
