There were questions as to how would diamond fees work for tournaments; with a \$30 fee for the ball fields, that could result in a 490 fee for the weekend. It was noted that many years ago when we had softball leagues that played on W/Th/F nights, they paid a fee of \$150 per team for the season. Member Fry made a motion to reduce non-profit fees to at least one half or more for consistency.

There was discussion of having a bulletin board at the park show what's rented.

Member Fry asked if we could see how much we have collected in the past from park fees.
